

 - 1. During the reception, speakers must face either North (toward the pond) or East (toward the right side of the tent). Speakers CANNOT face South or West due to neighboring houses.

- 2. There is a decibel meter under the tent in order to ensure we are not violating any county noise ordinances. The levels are attached to the decibel meter. Your DJ must have this meter in view at all times.
- 3. Music must be COMPLETELY OFF by 10pm (Sundays through Thursdays) or 11pm (Fridays and Saturdays). For the last song, please do not start a new song unless the song will be finished by the cut-off time. NO EXCEPTIONS.
- Please acknowledge that you have forwarded these rules to your DJ or the person in charge of handling your music during the reception (type "I acknowledge"):

- IMPORTANT: Please make sure all of your vendors know to enter the correct address into their GPS rather than just "1885 Farms". If they just enter "1885 Farms", their GPS will take them to The Barn (our other property). Vendors must enter "1764 Ben Fulton Ave NW, North Lawrence 44666" in order to be directed to the correct place.

11. This is the recommended setup (number of round tables will depend on guest count):



- Head table in front of pond
- All food tables on right (so the food remains shaded)
- o Cards/gifts/guestbook near where guests enter the tent
- o Appetizers near where guests enter the tent
- Bar near where guests enter the tent (shaded)

- Dessert in back near head table for couple to easily cut cake
- o DJ electrical box with speakers facing east
- Dance floor in center of tent (dance floor cannot be moved)
- Guest tables positioned evenly around throughout the tent
